Course Description	

An examination of contemporary approaches to the psychological study of language and speech, with emphasis on the biological, cognitive, and cultural aspects of language use. Topics include language comprehension, language production, and language disorders. Exclusion: JLP374H1; Prerequisite: <u>PSY201H5</u>/equivalent, <u>270H5</u>/ <u>274H5</u>/ <u>315H5</u>

By the end of this course, you should be able to:

- Describe core terms, concepts and theories explored in advanced topics in psycholinguistics
- Understand the multimodal nature of human communication and the implications for the architecture of the human mind and brain
- Understand differences in the conscious and unconscious processes involved in language comprehension and use
- Explain how experimental results support or refute theories about the nature of language behaviour
- Understand steps in the treatment of empirical data from psycholinguistic experiments
- Identify key variables in empirical research in psycholinguistics and infer evidence-based conclusions
- Describe ways in which our language processing abilities are connected to broader cognitive and social functioning

Missed Test Special Consideration Request Process

Students who miss a test due to circumstances beyond their control (e.g. illness or an accident) can request that the Department grant them special consideration. Students must present their case to the Department (NOT the Instructor) by submitting a request via the online Special Consideration Request form at: https://utmapp.utm.utoronto.ca/SpecialRequest.

Important note: Once the test/exam is available online or in-person and you're unable to write or have an approved request to miss, **DO NOT** at any point attempt to access/write the test/exam. If at any time you access the test/exam or sit down to write, you will **NOT** be able to submit a special consideration and/or your request will be refused.

If your request is approved by the department, a make-up test will be offered. You will receive an email when a make-up date has been arranged. The department will try to give 2-3 days notice of make-up date, however this is sometimes not possible. Be prepared in advance for the make-up test.

Extension of Time Special Consideration Request Process

Students who seek to be granted more time to complete their term work beyond the due date without penalty, owing to circumstances beyond their control (e.g., illness, or an accident), must do so by submitting a request **directly to the Instructor** for the period up to and including the last day of the term. The decision as to whether or not to apply a penalty for the specified period rests with the Instructor.

Students who seek to be granted more time to complete term work beyond the last day of the term must submit their request directly to the Psychology Department. This request covers the period following the last day of classes and ends the last day of the exam period. This is done by submitting a request via the online Special Consideration Request form at <u>https://utmapp.utm.utoronto.ca/SpecialRequest</u>. Course Outline

Please note that this outline is subject to change depending on the needs of the class (we may need additional time to cover a topic). Any changes to the syllabus will be announced in class one week before. However, the assignment and test dates are fixed.

The course is organized around three themes.

i. Language processing and the "human machine": What is the fundamental problem that our language processing systems have evolved to handle? How is language processing shaped by sensory modalities? Does our mental machinery differ according to whether we are monolingual or bilingual, or whether we are a younger versus older adult?

ii. Language processing and social interaction. What is the relationship between language and social cognition? To what degree do social phenomena influence core aspects of language processing? How do key psycholinguistic processes explain the way we are influenced by things like advertising or "fake news"?

ii. Language processing and emerging technology. How can "big data" inform our understanding of language behaviour? Could our individual language patterns reveal our personality or the onset of dementia? What is the current status of the language systems used in Artificial Intelligence? What happens when people communicate with robots?
