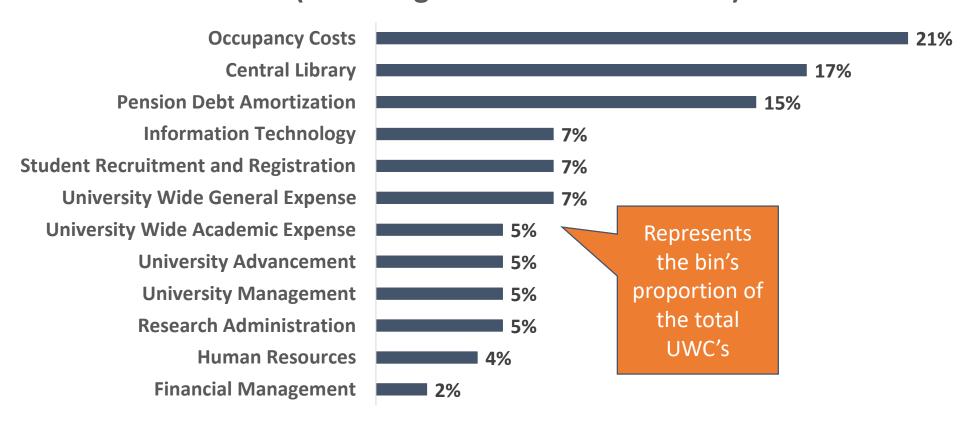

- Amounts for UG student aid are mainly for UTAPS bursaries, merit scholarships & Ontario Work Study.
- A newly introduced International Scholarship Set-Aside of 1.5% of international tuition revenue is new for 2020-21 to drive diversity of recruitment. This annual program cost is estimated to be \$3.6M. Awards on entrance are \$25K or \$45K and renewable for 3 years.
