The Certificate of Canadian Income Tax Practice prepares new CPAs, internationally trained accountants, and lawyers for a career in Canadian income tax practice. This includes:

- Experienced professionals (CPAs, lawyers, etc.) who do not currently practice in tax but are interested in expanding their tax knowledge or moving to a tax role.
- CPA students who have completed the CFE.
- Internationally trained accountants interested in pursuing a career in Canadian income tax.

Canadian income tax practice has become steadily more complex, but the traditional preparations for tax practice have not kept pace – and this gap is only widening.

The Certificate of Canadian Income Tax Practice fills this gap, and in the process makes future Canadian income tax practitioners more effective in their early careers, and better prepared for senior assignments in their mid and later careers.

By the end of the program, participants will be able to effectively prepare and review tax compliance, identify and manage important tax issues, conduct research, and incorporate technology to enhance their tax practice, enabling them to begin a productive career in tax practice with fewer miss-steps.

CURRICULUM

The Certificate of Canadian Income Tax Practice includes five courses that will help participants master and apply essential concepts and principles.

Courses include:

- Tax Basics I
- Tax Basics II
- Tax Basics III
- Financial Statements and Tax
- Introduction to Tax Law

A University of Toronto certificate will be awarded based on the successful completion of 2-3 practical assignments for each course and a minimum of 90% attendance.

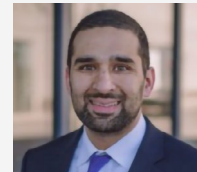
